

Official Minutes Regular Business Meeting September 22, 2020

The Central County Fire & Rescue Board of Directors held its Regular Monthly Business meeting on Tuesday, September 22, 2020, 6:00 PM, via video conferencing due to the current situation with the coronavirus. The meeting was called to order at 6:03 PM by Dave Tilley.

Resolution No. 20-156 – Resolution to set the 2020 General, Pension, and Debt Service Funds Tax Rate

There was a motion by David Bell and a second by Patricia Hamm to adopt Resolution No. 20-156. A roll call vote was taken. Chairman Dave Tilley read the title, Central County Fire & Rescue, A Fire Protection District Resolution No. 20-156. Resolution No. 20-156, establishing the 2020 General Fund, Pension and Debt Service Tax Levies for the District at the following rates:

- General Revenue \$0.9419
- Debt Service \$0.0780
- Pension \$0.0417

and setting the District's reimbursement rate at 100% in regard to Senate Bill 870.

Treasurer's Report

We are currently under budget by 9.87%. He recommended that we continue to be conservative. There was a motion by David Bell and a second by Patricia Hamm to approve the treasurer's report.
