Central County Fire and Rescue is seeking proposals for installation of an interior air sanitation/scrubbing system at each of the seven (7) facilities. Proposals received after 4:00 p.m. on Monday, August 17, 2020 will not be considered. The proposals will be opened and read publicly at 4:15 p.m., August 17, 2020. Proposals may be reviewed and awarded at a later date.

Sealed submissions must be received by CCFR at 1220 Cave Springs Blvd., St. Peters, MO 63376, no later than 4:00 p.m., August 17, 2020. A completed copy of this form must be included with the proposal. Two (2) copies of specifications are to be provided with each proposal. Page 5 of this document must be completed.

- Must be able to eliminate or reduce chemical, cooking, and other odors from interior air of the facilities.
- Any system or equipment installed cannot impede the operation or air flow of the HVAC system currently in use.
